#### 4. PRESIDENT'S REMARKS

Joanna M. Pinkerton, President/CEO, stated that her President's Remarks are very different this month due to what is happening in our community and world. While we are adjusting to everyday to the ever evolving situation, the one thing that has stayed constant is our commitment to people. We know that our team is being impacted professionally and personally. That is why we are offering virtual counseling to all employees during this time. Our immediate outcome is focused on preserving human life in Central Ohio and ensuring that people have access to essential services in our community.
