COVID-19 Response

Joanna M. Pinkerton, President/CEO, gave an update on steps that COTA has taken to address the COVID-19 pandemic. The Leadership Team meets twice daily to review data – including ridership and call-off rates – as well as to discuss how to best serve the needs of our community. Our team is thoroughly cleaning every bus every single day by disinfecting areas where customers touch. We are focused on stopping the spread by also issuing PPE equipment to employees – like gloves. Like many other companies, we are currently on a waitlist to receive masks, but hope to get enough in the coming weeks to be able to distribute to employees. We are preparing to rollout temperature checks for all employees in the coming weeks and have implemented a COVID-19 hotline where employees can call in to ask questions and report if they are experiencing symptoms.
